## Gazebo/Picnic Shelter/Pavilion Checklist Information

## Definitions for gazebo/picnic shelter/pavilion areas:

**Edge Protection**: Where railings, guards, or handrails are provided, edge protection must be provided and extend a minimum of 2 inches above the ground or deck surface. This protection will prevent persons using wheelchairs or other mobility devices from slipping off the platform.

**Turning Space**: Areas must have at least one turning area, either a 60-inch turning space or T-shaped space, to allow a person using a mobility device or wheelchair to make a 180-degree turn. The space may overlap the accessible route and clear floor or ground space.
