Golf Course and Driving Range Checklist Information

Definitions for Golf Courses and Driving Range facilities:

Teeing ground - the starting place for a hole of golf. It is a rectangular area usually two club lengths in depth, the teeing ground's borders are defined by the outside limits of two "tee-markers." The design and construction of new teeing grounds or the alteration of an existing teeing area must allow golf cars to enter and exit within these limits.

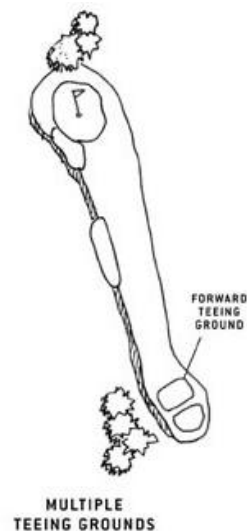
Forward teeing ground - located closer to the hole. If one or two teeing grounds are provided for a hole, only the forward teeing ground must be accessible by an accessible route or a golf cart passage. If there are three or more teeing grounds two must be accessible. This allows people with disabilities to play from different tees appropriate to their skill level, while providing flexibility to course operations and designers.

Course barriers - curbing or other human-made barriers often line golf cart paths to restrict golf carts from entering certain portions of the course or to reduce erosion. Where human-made barriers are provided that prevent golf carts from entering a fairway, openings at least 60 inches wide at intervals not exceeding 75 yards must be provided.

Course weather shelters - buildings that provide shelter from bad weather and even provide protection from the sun. They are located throughout the course. They are constructed to allow a golf cart to enter and exit and have a clear floor or ground space of 60" X 96" inches minimum.

Putting greens - areas of a golf course nearest the hole, with a smoother surface to make putting easier. Each putting green must be designed and constructed so that a golf cart can enter and exit the green. The green must be connected by a golf cart passage so that a golf cart can reach the green.

Driving ranges & teeing stations - stations are where an individual would drive the ball or practice her/his swing for driving the ball off of a tee. It is supposed to simulate the "teeing ground," which is the start of each hole on a golf course. The teeing stations must allow room for a golf cart to both enter and exit the station. Enter and exit width must be 60" inches or more.



Golf Course & Driving Range Accessibility Tool Information

Accessible routes are continuous, unobstructed paths connecting all accessible elements and space of a building or facility on golf courses.

At least 5 percent, but no fewer than one, of practice putting greens, practice teeing grounds, and teeing stations at driving ranges shall be designed and constructed so that a golf cart can enter and exit the practice putting greens, practice teeing grounds, and teeing stations at driving ranges. Accessible routes serving teeing grounds, practice teeing grounds, putting greens, practice putting greens, teeing stations at driving ranges, course weather shelters, golf car rental areas, bag drop areas, and course toilet rooms shall be 48 inches wide minimum. The 48 inch minimum width for the accessible route is necessary to ensure passage of a golf cart on either the accessible route or the golf cart passage. This is important where the accessible route is used to connect the golf car rental area, bag drop areas, practice putting greens, practice teeing grounds, course toilet rooms, and course weather shelters.
