## **Shooting Facility Checklist Information**

## **Definitions for Shooting Facilities:**

• Fixed firing positions - areas where a shooter will set up to take a shot.

## Additional information for completing the Shooting Facility Checklist:

If facilities provide fixed firing positions, at least 5 percent, but not less than one of each type of fixed firing position must be served by an accessible route. Fixed firing positions must have a 60-inch diameter space with slopes not steeper than 1:48 so a wheelchair user can turn around and have a level place from which to shoot.

Different types of firing positions include positions that support different shooting events, e.g., muzzle loading rifle, small bore rifle, high power rifle, bull's eye pistol, action pistol, silhouette, trap, skeet, and archery.

A circular turning space 60 inches diameter minimum with slopes not steeper than 1:48 (or 2.08%) shall be provided at shooting facilities with firing positions.
